

# **Beat the Peak!**

### Program Offers Members a Chance to Help

We need your help in controlling wholesale power costs. Wholesale power is Piedmont Electric's biggest expense. A large portion of that cost is determined on peak days, usually hot summer afternoons.

With your help, we will be able to reduce the summer peak load which will benefit the Cooperative with lower wholesale power costs.

The "Beat the Peak" program is designed to help you know when

**Stay on Top of Unsafe Products** 

Annually thousands of product recalls—many of them electrical devices—occur. Given that some recalls involve items that have already done great harm, it's important to stay on top of developments.

Recalls begin in two ways: A federal regulatory agency issues a mandatory recall, or the manufacturer voluntarily recalls the product after receiving information that it could be unsafe.

Stay on top of the dozens of recalls that are issued every

week with these key sources:

Several government agencies joined forces to create www.recalls. gov. In addition to having the latest information, www.recalls.gov allows users to keyword search through its archives.

The website also boasts a mobile phone application, which enables consumers to have information when and where they need it. Some of the agencies provide users with new information automatically every day. Some also use Facebook, Twitter and other applications to share information easily.

power costs are going to be high so you can take action.

As part of the "Beat the Peak" program, we will be asking you to adjust your thermostat, turn off lights and delay the use of major appliances on hot summer weekdays between 1 p.m. and 6 p.m.

Why participate? Piedmont Electric pays its wholesale power supplier significantly higher prices for power used during peak use times—and these costs have to be passed on to the Cooperative's members.

How does "Beat the Peak" program work? When Piedmont Electric thinks a peak situation is eminent, the Cooperative will send a text message or email to members who volunteer to participate. This information will also be posted on the website at www. pemc.coop.

Members will be asked to adjust their cooling system thermostats by at least three degrees and to limit their electricity use.

#### From Your President...

## What's Ahead in Power Costs?

There's never a good time to talk about the cost of anything increasing, and with our dependency on electricity, it's even harder news to bear.

Electricity prices are forecast to increase in the future. Numerous reasons factor into this prediction, including the fact the cost of coal, which fuels over half of our supplied electricity, has doubled in recent years.

Natural gas, a reasonable alternative to coal, is expensive and volatile in cost. Further, the cost of new power generation is rising and our wholesale suppliers are seriously contemplating building new power plants to meet the demand.

Another factor is increased energy regulation on the federal level, which will have cost implications as older coal plants are being replaced.

The Wholesale Power Cost Adjustment (WPCA) Rider has been used to adjust for the monthly variations of actual cost of power compared to the power cost recovered in the rates.

If the actual cost of wholesale

power is different from the cost of power in the rate design, a credit or charge is assessed to compensate for that difference.

The wholesale power cost is evaluated and applied monthly to the member's bills. The actual monthly cost of wholesale power changes each month because of load factor variations and changes to our power supplier's bills.

In November 2011, Piedmont Electric had to increase the WPCA to members because the fore-casted costs versus actual costs of our power supplier, Duke Energy, increased. The increase is not directly tied to the publicized Duke Energy request for a retail rate increase.

For the first seven months of 2011, Piedmont Electric actually had a negative WPCA, and between August and October the WPCA was nominal.

We cannot stop the cost of electricity from rising; however the Cooperative is looking out for the best interest of the members by helping them in finding ways to lower their electricity bills and keep their electricity affordable.

To this end, Piedmont Electric offers a variety of services and programs, including free home energy analyses, low interest Energy Efficiency and Renewable Loans to qualified members and rebates on heating and cooling systems, CFLs and solar water heaters.

As noted in the cover wrap of this magazine, as well as on the previous page, Piedmont Electric is starting a new program called "Beat the Peak."

By voluntarily reducing electricity use during peak hours members can help reduce the demand on the system—and help save on both the Cooperative's and their own power bills.

By working together, we can reduce the cost of power supply.



#### Persimmon Pudding

- 3 cups sugar
- 2 sticks margarine or butter
- 3 eggs
- I 14-ounce can Eagle Brand milk
- 2 cups persimmon pulp
- 2 teaspoons vanilla
- 2 teaspoons cinnamon
- 3 cups self-rising flour

Cream sugar and butter until fluffy; add eggs, one at a time, alternating with flour, then milk and persimmon pulp.

Add vanilla and cinnamon. Mix well. Pour into a large wellgreased baking dish. Bake at 325 degrees for one hour, or until cake leaves pan. Yields 15-20 servings.

# Four Scholarships Available

Once again Piedmont Electric will offer four \$1,000 scholarships for continuing education to high school seniors in

our service area who are planning to attend a four-year college or technical school.

The eligibility requirements for a scholarship are as follows:

- Applicant's parent must be a member of Piedmont Electric.
- One scholarship winner per family per year.
- · Applicant is a qualified high school senior planning to continue his/her education at an accredited community college, university or technical school.
  - Applicants must submit:
- -Completed application form, available at www.pemc.coop (Go to Schools and Community/Scholarship Application)
- —Copy of college acceptance letter and copies of ACT or SAT
- -Official high school transcript listing courses taken and grade point average (GPA) of at least 3.0

Also, applicants should have participated in high school or outside extracurricular activities and in at least one community-related volunteer project.

-Submission of a letter of reference from teacher, counselor, employer or community person, and a short essay written by applicant on the topic: "Describe your rural electric cooperative and how it differs from other businesses" are also required.

Financial need is not a criterion for the scholarship.
