Phase II Rebates Begin

Phase II of the North Carolina Energy Efficient Appliance Replacement and Rebate Program launches June I with more eligible appliances and a lot less money for rebates.

The state has just \$1 million to hand out. Rebates will be given on a first-come, first-serve basis starting June I and



continuing until the money runs out.

While the money is limited, the list of products eligible for the rebate has grown to include Energy Star-rated central air conditioning systems, gas furnaces, air-source and ground-source heat pumps and water heaters (gas storage, gas tankless, solar with electric backup and solar with gas backup).

As in the first phase, rebates will be offered for Energy Star-rated refrigerators, freezers, washing machines and dishwashers. Consumers must be replacing an old appliance to claim the rebate.

Only purchases made on or after June I will be eligible for the rebate.

Consumers will be able to reserve rebates online beginning June I. They will then have two weeks after reserving each rebate to mail in the rebate application and required address and proof-ofpurchase information to the state.

The state will pay the following rebate amounts: air conditioning systems, \$300; washing machines, \$100; dishwashers, \$75; refrigerators, \$150; freezers, \$75; gas furnaces, \$300; heat pumps, \$300, and water heaters, \$200.



Annual Meeting Provides Interactive Displays, 2009 **Review, Future Plans**

"Our most notable accomplishment in 2009 was the completion of our Smart Metering program." CEO R.G. Brecheisen told members attending the Cooperative's annual meeting.

"The program will serve as the foundation as we work to empower our members to use energy more efficiently with new programs for years to come," he explained, adding that Piedmont Electric is the first electric utility in the state to fully deploy Smart Metering.

At the core of his message, Brecheisen emphasized the effect of potential legislative action on consumers' electricity bills.

"Some of the proposals being considered would be very costly, and would ultimately have to be paid for by consumers in the form of higher electric rates," he said.

"We already have members who are struggling to pay electricity bills today, and if adopted, some of these proposals could potentially cause rates to double in the nearterm future."

Piedmont Electric believes we need an energy policy that recognizes the need for energy efficiency, renewable energy resources and new clean energy from nuclear and clean coal technologies, the CEO said.

He urged members to contact their elected officials to express their concern over potentially costly federal legislation.

An audiovisual presentation, "Together We Save," gave an overview of the Cooperative's programs and accomplishments during 2009.

During summer months when air conditioners work hardest, do energy-intensive tasks such as laundry and dish washing during offpeak energy demand hours, usually in the morning or later evening. do to help, including using the automated outage reporting number.

Employees are always on call for those who prefer to speak with a "live" person and to take details of things like trees on the line which may be the cause of your outage.

We hope we will avoid devastating weather, but please know Piedmont Electric is doing everything we can to be prepared just in case.

AREYOU PREPARED FOR HURRICANE SEASON?

Advancements in technology allow us more time to prepare for forecasted hurricanes, but these storms still pose a serious threat —even as far inland as the Piedmont part of the state.


Hurricane season begins June I and ends November 30. Use these tips and guidelines to get ready before the season starts. *Before the Storm*

Discuss a family disaster plan. Identify ahead of time where you will go if you're told to evacuate.

Locate important papers and documents and have them ready to take with you should you need to evacuate: driver's licenses, Social Security cards, proof of residence, insurance policies, wills, deeds, birth and marriage certificates, tax records and photos of your home (exterior and interior). Store these items in a waterproof container:

Create an inventory of your personal belongings with videotape, photos or a written list. Make sure this inventory list is also kept in a waterproof container.

Have a supply of water,



non-perishable food items, a first-aid kit, flashlights, a batteryoperated radio, batteries and your prescription medications.

Be sure to consider the special needs of babies and the elderly and pack the appropriate supplies.

Call friends, family members, veterinarians or boarding kennels in a safe location to arrange foster care if you and your pets cannot stay together. Most emergency shelters do not admit pets.

Fill your car with gas as soon as a storm is forecasted; do not wait. When a Hurricane Watch Is Issued

A watch is issued when there is a threat of hurricane conditions within 24-36 hours.

Follow television or radio hurricane progress reports.

Review your evacuation plan.
When a Hurricane Warning Is Issued

• Warnings are issued when hurricane conditions are expected in less than 24 hours.

Listen constantly to a television or radio for official instructions.

If you live in a mobile home, check tie-downs and evacuate immediately.

If Officials Say Evacuation is Necessary

Leave as soon as possible. Remember, during an evacuation, primary and many secondary roads might be clogged with traffic, so allow ample time to get out.

Unplug appliances to prevent damage in case of a power surge.

A light inside the house should be left on to signal when power has been restored.

Take protective clothing, blankets and sleeping bags.

Lock up your home and leave.

After the Storm

Make sure the storm has completely passed before going outside.

Stay away from downed power lines and report them to Piedmont Electric.

If your power is out for an extended period of time, and your emergency situation requires the use of a generator, have a qualified, licensed electrician connect the generator to your home's main electrical supply.

Power from generators can backfeed along power lines and electrocute anyone who comes into contact with them.

Hurricane preparation is essential to minimize the risk of damage and injury to your home and family.

To lessen the potential consequences surrounding hurricane season, start gathering supplies, preparing your home and planning for a possible storm before the hurricane season starts.
