By the Numbers...

- 840 members have signed up for the use monitoring portion of www.MyUsage.com
- 315 members are participating in the Pre-Pay Program
- 306 members have turned in receipts for 3,125 CFLs, representing a total of 1,071,875 kWhs saved toward our Senate Bill 3 Mandate

IT WAS 22% COLDER...

These past months have brought extremely cold

temperatures to our area, and the effects are still being felt as you begin receiving the bills for heating your homes.
Piedmont Electric member-consumers set an all time high record for energy sold. That translates into high

electricity bills.

Degree-days are used by utilities to measure weather changes and this past winter had higher than normal degree days.

Degree-day is a measurement of how much the average daily temperature varies from a standard reference temperature.

Last December and January we had 1,304 degree days while this winter for the same months, we had 1,587 degree days, that's 22% colder.

The 30-year average is 1,462 degree days.

Please consider these significant increases in degree-days when you get your electricity bills over this winter. The bottom line is that the colder temperatures will affect your bills.

energy suppliers.

To date we have completed a three-year conversion to "smart" meters which offers members several options for managing their energy use, including a flex payment program for those who want to pay for electricity before it's used.

All members have the capability to check their electricity use through the website MyUsage.com.

Currently, data is available up to the previous day's use, and we are investigating options which will allow you to see use in real/current time.

The Cooperative is already ahead of every other electric utility in the state—including investor-owned utilities—in providing smart meters to all of its members.

In keeping with our mission statement, Piedmont Electric is actively working to meet the challenges concerning environmental issues, the need for new electricity generation, the rising cost of fuels for generation and the increasing cost of electricity.

In the last few years, we have worked toward the installation of a solar array field at our Caswell office with MegaWatt Solar, Inc.,to help meet our N.C. Senate Bill 3 mandates.

Other renewable energy projects are in the works.

We have become a partner in the government's Energy Star Program to offer members initiatives to manage their energy use more efficiently.

Piedmont Electric has also offered additional programs such as compact fluorescent lights (CFLs) and solar water heater rebates.

In keeping with our mission, the Cooperative is converting existing mercury vapor security lights to more efficient sodium lights.

Keeping you, our members, informed on all of these programs which will allow you to manage your energy costs more effectively, is of utmost importance.

Further, we are committed to keeping our elected representatives informed about how proposed energy legislation will affect you.

We have been asking you to join our grassroot effort—Our Energy, Our Future—by contacting your elected officials on issues affecting energy concerns.

Your electric cooperative continues to investigate additional tools which will empower you to make wise energy decisions.

With your help Piedmont Electric can meet today's energy challenges and be ready for the challenges of the future.

Electric Water Heater Wrap

Kits are available at our offices. An installed

kit can

lower water heating costs up to \$100 annually. The price for Piedmont Electric members is \$15, plus tax, for the kit.

Multiple Account Set-up Requires Help

As the number of members taking advantage of the MyUsage.com website increases, we have found that those who want to monitor multiple accounts need help in get-

ting their information.

Members may setup as

many accounts as they want, but it would require a different email for each account—unless they contact the Cooperative for assistance.

If the member has only one email address, a Piedmont Electric representative will help setup the additional accounts. Currently the member cannot do it.

MyUsage.com, a free service

for members of the Cooperative, allows member-consumers to track how much electricity they have used during the preceding day and beyond.

By monitoring their electricity use, consumers can determine

what factors, such as weather or other high use activities, have on the amount of electricity consumed.

Members who have only one account they want to monitor can set up the account themselves. The account and meter numbers, which are located on the monthly statement, is necessary for setting up entry into MyUsage.com.

Know What to Do if Car Contacts Power Line

If your car comes in contact with a power line, try to stay calm and follow these tips:

Remain inside your vehicle. If you are in your car, you are not part of electricity's path, which always looks for the shortest way to the ground. Honk your horn to alert passersby.

· If someone stops to help, roll down the window and warn them not to touch the car or the power line. Ask them to phone 911 and contact the local electric utility immediately.

·Wait in your car until qualified

electrical workers turn the power off and tell you it's safe to leave the car.

· If you have to leave the car because of fire or other danger, open the door and jump away from the vehicle so no part of your body touches the vehicle and the ground at the same time. Make sure to jump with both feet together so that your feet land on the ground at the same time.

· After you land with both feet together, shuffle away, keeping both feet in contact with the ground constantly.

Sour Cream Pound Cake

- 3 cups sugar
- 2 sticks margarine
- 3 cups cake flour
- 1/2 cup Crisco oil
- I teaspoon baking powder
- I teaspoon vanilla flavoring
- I teaspoon lemon flavoring
- 5 eggs
- 1/4 cup milk
- 8 ounces sour cream

Do NOT preheat oven.
Mix margarine and oil together. Add sugar. Break eggs in a bowl and beat with a fork until fluffy. Add remaining ingredients. Pour into greased and floured bundt pan. (PAM® for Baking with Flour preferred.)

Bake at 300° to 325° for one hour.

NRECA Leads Efforts to Restore Power in Haiti

After a devastating earthquake left much of Haiti's capital in ruins, a team from the National Rural Electric Cooperative Association (NRECA) International is helping to restore electricity to hospitals and other facilities critical to the city's recovery.

A damage assessment of Haiti's national electric company's facilities in the Port-au-Prince area found three substations with significant damage, but other parts of the system are in better condition. The transmission and distribution circuits sustained relatively minor damage.

NRECA's team is working with other international and local relief agencies to get emergency power



to key facilities including medical aid and food distribution sites and police stations.

The NRECA Foundation continues to seek donations to its International Haiti Relief Fund.
